AN ORDINANCE TO VACATE A 30x440 RECTANGULAR PIECE OF PROPERTY, BEING EASTERLY OF WESTERN AVENUE AND WESTERLY OF CENTER STREET, KNOWN AS BIRCH STREET, SHOWN IN PLAT BOOK 7 AT PAGES 126 and 127 IN THE RECORDER'S OFFICE, SANDY BEACH ADDITION, LINCOLN TOWNSHIP, LAPORTE COUNTY, INDIANA

WHEREAS, HENRY E. SNYDER and LORA LEE SNYDER and CLARENCE H. SYDOW, and LAWRENCE STAEHLIN and FRANCES STAEHLIN, have filed their petition, pursuant to I.C. 36-7-3-12, with the Board of County Commissioners of LaPorte County, Indiana, asking that a certain 30x440 rectangular piece of property known as Birch Street in Sandy Beach Addition, lying easterly of Western Avenue and Westerly of Center Street, Lincoln Township, LaPorte County, Indiana, more particularly described as follows, be vacated, to-wit:

A parcel of land 30x440 feet rectangular lying easterly of Western Avenue and Westerly of Center Street, shown in Plat Book 7 at pages 126 and 127 in the Recorder's Office, LaPorte County, Indiana, known as Sandy Beach Addition, Lincoln Township commonly known and referred to as Birch Street

WHEREAS, following the filing of said petition, the Board of County Commissioners scheduled a public hearing thereon to be held on this date; and,

WHEREAS, the Clerk of the Board of County Commissioners of LaPorte County, Indiana, did give notice of the filing of this petition and of the hearing thereon by publication in the manner prescribed by I.C. 5-3-1-1 et seq and that no notice by certified mail was necessary since all property abutting the above-described real estate to be vacated is owned by the petitioners; and,

WHEREAS, the Board of County Commissioners, as the legislative body of LaPorte County, Indiana, have now conducted the public hearing on the petition to vacate and have determined that said property should be vacated, all as permitted by I.C. 36-7-3-12.

Section 1.

BE IT AND IT IS HEREBY ORDAINED by the Board of County Commissioners of LaPorte County, Indiana, that the following described real estate situated in LaPorte County, State of Indiana, to-wit:

A parcel of land 30x440 feet rectangular lying easterly of Western Avenue and westerly of Center Street, shown in Plat Book 7 at pages 126 and 127 in the Recorder's Office, LaPorte County, Indiana, known as Sandy Beach Addition, Lincoln Township commonly known and referred to as Birch Street

Section 2.

The Clerk of the Board of County Commissioners of LaPorte County, Indiana, shall furnish a copy of this vacation ordinance to the LaPorte County Recorder in order that the same may be placed of record in the records of the Recorder's Office, and shall also furnish a copy to the LaPorte County Auditor.
