AN ORDINANCE TO VACATE AN ALLEY THAT DIVIDES
LOTS 2 AND 3 IN BLOCK 12
IN HANNA, IN HANNA TOWNSHIP,
LAPORTE COUNTY, INDIANA

WHEREAS, Russell W. G. Looney and Laura L. Looney,
husband and wife, of LaPorte County, Indiana, have filed a
petition, pursuant to I.C. 36-7-3-12, with the Board of County
Commissioners of LaPorte County, Indiana, asking that a certain
alley, located in Hanna Township, be vacated. Said alley
divides the following described real estate, to-wit:

body of LaPorte County, Indiana, has now conducted the public
hearing on the petition to vacate and has determined that the
alley described above should be vacated, all as permitted by
I.C. 36-7-3-12;

in Plat Book 1, page 180


be, and the same is, hereby vacated as a public way.


