ORDINANCE NO. 89-8

**AN ORDINANCE TO VACATE A STREET THAT  
ABUTS OR ADJOINS LOTS 10 AND 11 IN PINEBROOK 3RD  
ADDITION AN LOTS 38 and 39 IN PINEBROOK 4TH  
ADDITION, COOLSPRING TOWNSHIP, LA PORTE COUNTY, INDIANA**

WHEREAS, David L. Wagner, Michael A. Pawlik and Patricia A. Pawlik, of La Porte County, Indiana, have filed a petition, pursuant to I.C. 36-7-3-12, with the Board of County Commissioners of La Porte County, Indiana, asking that certain streets be vacated, which certain streets are located in Pinebrook Third Addition and Pinebrook Fourth Addition, Coolspring Township, La Porte County, Indiana, and being more particularly described as follows, to-wit:

An unnamed street between Lots 38 and 39 in Pinebrook Fourth Addition and an unnamed street between Lots 10 and 11 in Pinebrook Third Addition as set forth in the plats recorded in the Office of the Recorder of La Porte County, Indiana.  
(a copy of a map showing the areas to be vacated is attached hereto, marked Exhibit A and made a part hereof by reference)

and,

WHEREAS, following the filing of this petition the Board of County Commissioners scheduled a public hearing thereon to be held on this date; and,

WHEREAS, the Clerk of the Board of County Commissioners of La Porte County, Indiana, did give notice of the filing of this petition and of the hearing thereon by publication in the manner prescribed in I.C. 5-3-1-1 et seq, and by certified mail to each owner, other than the petitioners, of land that abuts the property which the petitioner is asking to be vacated; and,

WHEREAS, the Board of County Commissioners, as the legislative body of La Porte County, Indiana, has now conducted the public hearing on the petition to vacate and has determined that the street described above should be vacated, all as permitted by I.C. 36-7-3-12;

NOW, THEREFORE,

Section 1. Be it and it is hereby ordained by the Board of County Commissioners of La Porte County, Indiana, that the following

described real estate situated in La Porte County, State of Indiana,  
to-wit:


