AN ORDINANCE TO VACATE AN ALLEY  
THAT DIVIDES LOT 6 AND LOTS 7 & 8  
IN BLOCK 3 OF YOUNG'S ADDITION  
TO HANNA, IN HANNA TOWNSHIP,  
LA PORTE COUNTY, INDIANA

WHEREAS, Joel M. Cooper and Joyce Ann Cooper, husband and wife, of La Porte County, Indiana, have filed a Petition, pursuant to I.C. 36-7-3-12, with the Board of County Commissioners of La Porte County, Indiana, asking that a certain alley, located in Hanna Township, be vacated. Said alley divides the following described real estate, to-wit:

WHEREAS, the Clerk of the Board of County Commissioners of La Porte County, Indiana, did give notice of the filing of this

Petition and of the hearing thereon by publication in the manner prescribed in I.C. 5-3-1-1 et seq, and by certified mail to each owner, other than Petitioner, of land that abuts the property which the Petitioner is asking to be vacated; and,

WHEREAS, the Board of County Commissioners, as the legislative body of La Porte County, Indiana, has now conducted the public hearing on the Petition to Vacate and has determined that the alley described above should be vacated, all as permitted by I.C. 36-7-3-12;

Section 1. Be it and it is hereby ordained by the Board of County Commissioners of La Porte County, Indiana, that the alley dividing the following described real estate situated in La Porte County, State of Indiana, to-wit:

Lot Seven (7) in Block Three (3) of Young's  
Addition to the Town of Hanna, Hanna  
Township, La Porte County, State of Indiana;

Lot Eight (8) in Block Three (3) of Young's  
Addition to the Town of Hanna, Hanna  
Township, La Porte County, State of Indiana;

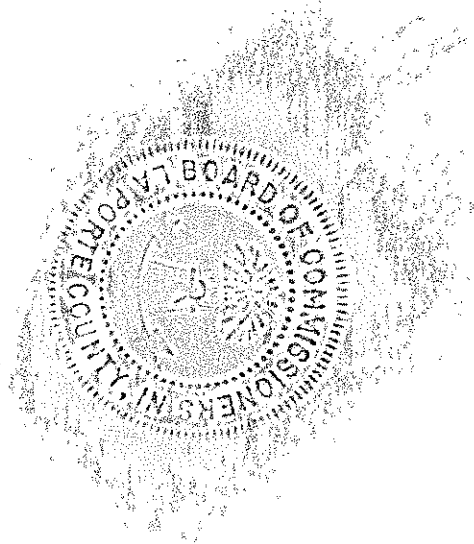
