ORDINANCE NO. 91-3

AN ORDINANCE TO VACATE STREETS THAT ABUT OR  
ADJOIN LOTS 158-168, 252-272, SANDY BEACH ADDITION  
TO LOWER FISH LAKE, LA PORTE COUNTY, INDIANA

WHEREAS, James A. Stovall and Anna Marie Stovall, of La Porte County, Indiana, have filed a petition, pursuant to I.C. 36-7-3-12, with the Board of County Commissioners of La Porte County, Indiana, asking that certain streets be vacated, which certain streets are located in Sandy Beach Addition, La Porte County, Indiana, and being more particularly described as follows, to-wit:

The first street to be vacated is the portion of Lake Shore Drive in the Sandy Beach Addition to Lower Fish Lake between Birch Street and the southwest side of lot 268 and the northwest side of lot 267. The second street to be vacated is Cherry Street in the Sandy Beach Addition to Lower Fish Lake between Fish Lake and ending at Lake Shore Drive.

and,

WHEREAS, following the filing of this petition the Board of County Commissioners scheduled a public hearing thereon to be held on this date; and,

WHEREAS, the Clerk of the Board of County Commissioners of La Porte County, Indiana, did give notice of the filing of this petition and of the hearing thereon by publication in the manner prescribed in I.C. 5-3-1-1 et seq, and by certified mail to each owner, other than the petitioners, of land that abuts the property which the petitioner is asking to be vacated; and,

WHEREAS, the Board of County Commissioners, as the legislative body of La Porte County, Indiana, has not conducted the public hearing on the petition to vacate and has determined that the street described above should be vacated, all as permitted by I.C. 36-7-3-12;

NOW, THEREFORE,

Section 1. Be it and it is hereby ordained by the Board of County Commissioners of La Porte County, Indiana, that the following described real estate situated in La Porte County, State of Indiana, to-wit:

The first street to be vacated is the portion of Lake Shore Drive in the Sandy Beach Addition to Lower Fish Lake between

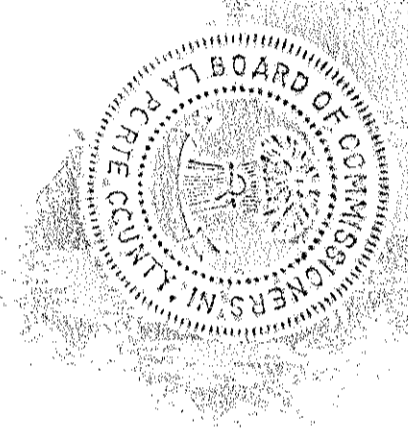

Birch Street and the southwest side of lot 268 and the northwest side of lot 267. The second street to be vacated is Cherry Street in the Sandy Beach Addition to Lower Fish Lake between Fish Lake and ending at Lake Shore Drive.

be, and the same is, hereby vacated as a public way.

Section 2. The Clerk of the Board of County Commissioners of La Porte County, Indiana, shall furnish a copy of this vacation ordinance to the La Porte County Recorder in order that the same may be placed of record in the records of the Recorder's Office, and shall also furnish a copy to the La Porte County Auditor.
