AN ORDINANCE FOR THE VACATION OF A
PORTION OF CEDAR LANE
IN HUDSON LAKE BEACH SUBDIVISION, LA PORTE, INDIANA

WHEREAS, pursuant to Petition of JAMES K. CURTIN and DONNA L. CURTIN, husband and wife, IVAN WATKINS and BETTY WATKINS, husband and wife, and DOUGLAS NEUMAN, a bachelor, for the vacation of a certain portion of Cedar Lane, and after proper notice and hearing thereon, the Board of County Commissioners of LaPorte County, Indiana, hereby adopt the following ordinance for vacation thereof:

Be it ordained by the board of County Commissioners of LaPorte County, Indiana, under the authority of the INDIANA CODE 36-7-3-12 of the Acts of 1988, as amended, General Assembly of the State of Indiana:

1. That the following portion of Cedar Lane, Hudson Lake Beach Subdivision, LaPorte County, Indiana, if hereby vacated:

Commencing at the Northwest corner of lot 1354 in Hudson Lake Beach subdivision, thence westerly thirty (30) feet more or less to the Northeast corner of lot 1422 in said subdivision, thence southerly two hundred sixty (260) feet more or less to the southeast corner of lot 1434 in said subdivision; thence easterly thirty (30) feet more or less to the southwest corner of lot 1342; thence northerly two hundred sixty (260) feet more or less to the northwest corner of lot 1354 to the point of beginning, being a portion of Cedar Lane in Hudson Lake Beach Subdivision, LaPorte County, Indiana lying between and adjacent to lots 1342 through 1354 and lots 1422 through 1434 in Hudson Lake Beach Subdivision, LaPorte County, Indiana.

2. That the ownership of said vacated portion of Cedar Lane shall be divided so that the easterly one-half (1/2)

thereof shall become vested in ownership in the respective owners of lots 1342 through 1354, Hudson Lake Beach Subdivision, LaPorte County, Indiana, which abut said Cedar Lane; and the westerly one-half (1/2) thereof shall become vested in ownership in the respective owners of lots 1422 through 1434, Hudson Lake Beach Subdivision, LaPorte County, Indiana, which abut said Cedar Lane.
