AN ORDINANCE TO VACATE A PORTION OF LA PORTE BOULEVARD THAT
ABUTS LOTS 3425 to 3428 AND LOTS 3336 to 3345
IN HUDSON LAKE BEACH
HUDSON TOWNSHIP LA PORTE COUNTY, INDIANA

WHEREAS, Richard I. Polanek, Rosemary Polanek, Thomas Brady and Kathleen R. Brady, have filed a petition, pursuant to I.C. 36-7-3-12, with the Board of County Commissioners of La Porte County, Indiana, asking that a portion of La Porte Boulevard located in Hudson Lake Beach, Hudson Township, and being more particularly described as follows, be vacated, to-wit:

The southerly portion of La Porte Boulevard bordering Lots 3425 to 3428 on the West side, and bordering Lots 3336 to 3345 on the East side, in Hudson Lake Beach, being a Subdivision of Part of Sections 21 and 28, Township 38 North, Range 1 West of the Second Principal Meridian, La Porte County, Indiana, as recorded in Plat Book 6, Page 18, which portion of La Porte Boulevard is more particularly described as follows: Commencing at the Northeast corner of Lot 3425; thence East across La Porte Boulevard to the Northwest corner of Lot 3345; thence South along the East line of La Porte Boulevard and the West line of Lots 3345 through 3336 to the Southwest corner of Lot 3336; thence Northwesterly to the Southeast corner of Lot 3428; thence North along the West line of La Porte Boulevard and the East line of Lots 3428 through 3425 to the point of beginning, and,

WHEREAS, following the filing of this petition the Board of County Commissioners scheduled a public hearing thereon to be held on this date; and,

WHEREAS, the Clerk of the Board of County Commissioners of La Porte County, Indiana, did give notice of the filing of this petition and of the hearing thereon by publication in the manner prescribed by I.C. 5-3-1-1 et seq; and,

WHEREAS, there were no other persons who owned property that abutted this portion of La Porte Boulevard who needed to be given notice of the filing of this petition; and,

WHEREAS, the Board of County Commissioners, as the legislative body of La Porte County, Indiana, has now conducted the public hearing on the petition to vacate and has determined that the portion of La Porte Boulevard described above should be vacated, all as permitted by I.C. 36-7-3-12;

Section 1. BE IT, AND IT IS, HEREBY ORDAINED by the Board of County Commissioners of La Porte County, Indiana, that the following described real estate situated in La Porte County, State of Indiana, to-wit:

The southerly portion of La Porte Boulevard bordering Lots 3425 to 3428 on the West side, and bordering Lots 3336 to 3345 on the East side, in Hudson Lake Beach, being a Subdivision of Part of Sections 21 and 28, Township 38 North, Range 1 West of the Second Principal Meridian, La Porte County, Indiana, as recorded in Plat Book 6, Page 18, which portion of La Porte Boulevard is more particularly described as follows: Commencing at the Northeast corner of Lot 3425; thence East across La Porte Boulevard to the Northwest corner of Lot 3345; thence South along the East line of La Porte Boulevard and the West line of Lots 3345 through 3336 to the Southwest corner of Lot 3336; thence Northwesterly to the Southeast corner of Lot 3428; thence North along the West line of La Porte Boulevard and the East line of Lots 3428 through 3425 to the point of beginning, be, and the same is, hereby vacated as a public way.

The Clerk of the Board of County Commissioners of La Porte County, Indiana, shall furnish a copy of this vacation ordinance to the La Porte County Recorder in order that the same may be placed of record in the records of the Recorder's Office, and shall also furnish a copy to the La Porte County Auditor.
