

AN ORDINANCE TO VACATE WEST END STREET,
IN HUDSON LAKE SUBDIVISION
OF LA PORTE COUNTY, INDIANA

WHEREAS, Kirk Snedden and Gayle Snedden, of LaPorte County, Indiana, by their attorney, George C. Patrick, have filed a petition, pursuant to Indiana Code 36-7-3-12, with the Board of Commissioners of LaPorte County, Indiana, asking that a certain street be vacated, which certain street is located in the Hudson Lake Subdivision, Hudson Township, LaPorte County, Indiana, and being more particularly described as follows, to-wit:

All of West End Street between Lots 5698, 5699, 5700, 5701, located in Hudson Lake Subdivision, Hudson Township, LaPorte County, Indiana.

and,

WHEREAS, following the filing of this petition the Board of County Commissioners scheduled a public hearing thereon to be held on this date; and,

WHEREAS, the Clerk of the Board of County Commissioners of LaPorte County, Indiana, did give notice of the filing of this petition and of the hearing thereon by publication in the manner prescribed in Indiana Code 5-3-1-1 et seq., and by certified mail to each owner, other than the petitioners, of land that abuts the property which the petitioner is asking to be vacated; and

WHEREAS, the Board of County Commissioners, as the legislative body of LaPorte County, Indiana has now conducted the public hearing on the petition to vacate and has determined that the street described above should be vacated, all as permitted by Indiana Code 36-7-3-12;





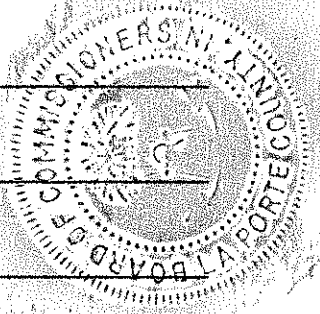
