

ORDINANCE OF THE LAPORTE COUNTY
BOARD OF COMMISSIONERS
NO. 94-10

WHEREAS, the Board of Commissioners of LaPorte County is responsible for formulating County Road policy consistent with the Statutes of the State of Indiana; and,

WHEREAS, the Board of Commissioners of LaPorte County recognize that a hazardous situation exists and have decided, therefore, that it is necessary to establish a thirty (30) miles per hour speed zone on Indian Trail, Laxita Drive, Verma Drive and Ladd Drive in Indian Estates Subdivision with entrances on U.S. 35 and C.R. 525 W. in Springfield Township; and,


WHEREAS, the Board of Commissioners of LaPorte County have the authority under Indiana Code 9-21-5-6 to establish the rate of speed on designated roadways;

IT IS THEREFORE ORDAINED:


1. That pursuant to Indiana Code 9-21-5-6 it shall be unlawful for any vehicle to exceed thirty (30) miles per hour on Indian Trail, Laxita Drive, Verma Drive, and Ladd Drive in Indian Estates Subdivision with entrances on U.S. 35 and C.R. 525 W. in Springfield Township;
2. That the LaPorte County Highway Department is hereby directed and ordered to post said road with signs indicating thirty (30) miles per hour;
3. That after the roadway has been posted in accordance with paragraph 2, herein, it shall be an infraction under Indiana Code 9-21-5-6 for any person to violate this ordinance.

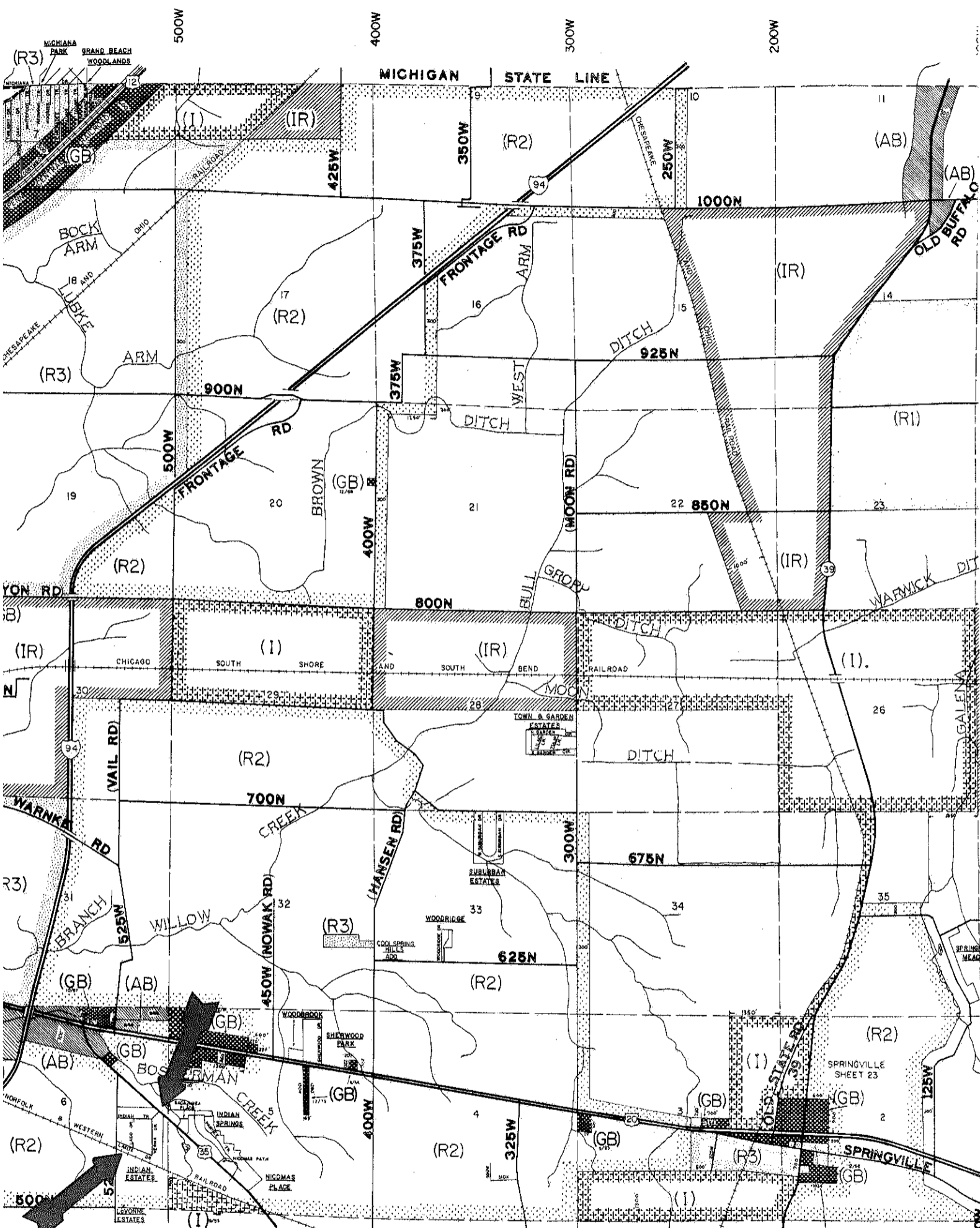

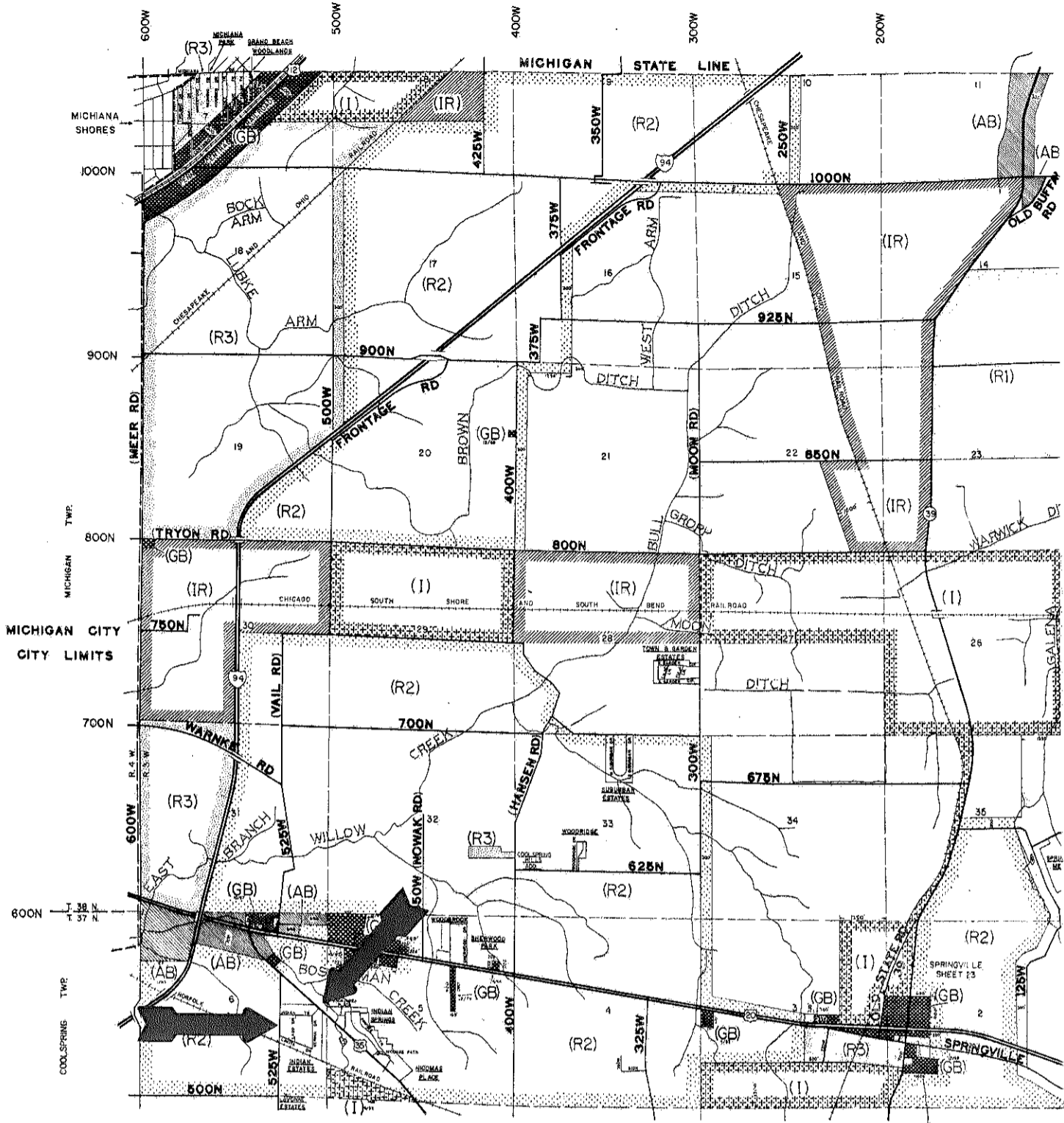

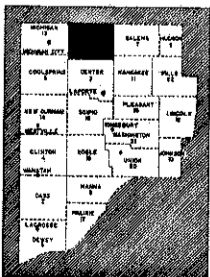
