ORDINANCE NO. 94-11

AN ORDINANCE TO VACATE EAST RIDGE AVENUE  
IN HUDSON HEIGHTS  
HUDSON TOWNSHIP LA PORTE COUNTY, INDIANA

WHEREAS, Charles A. Freestone and Betty C. Freestone, as the fee owners, have filed a petition, pursuant to I.C. 36-7-3-12, with the Board of County Commissioners of La Porte County, Indiana, asking that East Ridge Avenue located in Hudson Township, and being more particularly described as follows:

All of East Ridge Avenue recorded in Plat Book 6, Page 32, which is bounded on the west by Lots 44, 45, 46, and 47, on the north by Lake View Avenue, on the South by South Hudson Avenue, and on the east by Lots 41, 42, and 43 in Hudson Heights, Hudson Township, LaPorte County, Indiana;  
and,

WHEREAS, following the filing of this petition the Board of County Commissioners scheduled a public hearing thereon to be held on June 20, 1994; and,

WHEREAS, the Clerk of the Board of County Commissioners of La Porte County, Indiana, gave notice of the filing of this petition and of the hearing thereon by publication in the manner prescribed by I.C. 5-3-1-1 et seq; and,

WHEREAS, there were no other persons who owned property that abutted East Ridge Avenue who needed to be given notice of the filing of this petition; and,

WHEREAS, the Board of County Commissioners, as the legislative body of La Porte County, Indiana, has now conducted the public hearing on the petition to vacate and has determined that East Ridge Avenue, described above should be vacated, all as permitted by I.C. 36-7-3-12;

NOW THEREFORE,

Section 1. BE IT, AND IT IS, HEREBY ORDAINED by the Board of County Commissioners of La Porte County, Indiana, that the following described real estate situated in La Porte County, State of Indiana, to-wit:

All of East Ridge Avenue recorded in Plat Book 6, Page 32, which is bounded on the west by Lots 44, 45, 46, and 47, on the north by Lake View Avenue, on the South by South Hudson Avenue, and on the east by Lots 41, 42, and 43 in Hudson Heights, Hudson Township, LaPorte County, Indiana,

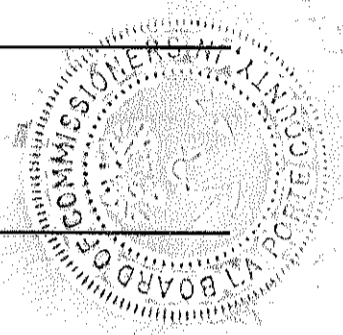
