BARBARA L. EULER AN RECORDER LA PORTE CO. ORDINANCE TO VACATE A PORTION OF OAK STREET IN ROLLING PRAIRIE KANKAKEE TOWNSHIP, LAPORTE COUNTY, INDIANA

WHEREAS, Charles D. Porter, Marcia C. Porter, David C. Jones and Sherry A. Jones, as the fee owners, have filed a petition, pursuant to I.C. 36-7-3-12, with the Board of County Commissioners of LaPorte County, Indiana, asking that a portion of Oak Street located in Rolling Prairie, Kankakee Township, and more particularly described as follows:

All of Oak Street bounded on the south by West Walker Street and on the north by Ludlow Street, and bounded on two sides by Lots One (1) and Six (6), Block Sixteen (16) and Lots Three (3) and Four (4), Block Fifteen (15), B.P. Walker's 2nd addition to Rolling Prairie, LaPorte County, Indiana; and,

WHEREAS, following the filing of this petition the Board of County Commissioners scheduled a public hearing thereon to be held on August 15, 1994; and,

WHEREAS, the Clerk of the Board of County Commissioners of LaPorte County, Indiana, gave notice of the filing of this petition and of the hearing thereon by publication in the manner prescribed by I.C. 5-3-1-1 et seq; and,

WHEREAS, there were no other persons who owned property that abutted Oak Street who needed to be given notice of the filing of this petition; and,

WHEREAS, the Board of County Commissioners, as the legislative body of LaPorte County, Indiana, has now conducted the public hearing on the petition to vacate and has determined that Oak Street between the north side of West Walker and the south side of Ludlow Street, described above, should be vacated, all as permitted by I.C. 36-7-3-12;

NOW THEREFORE,

Section 1. BE IT, AND IT IS, HEREBY ORDAINED by the Board of County Commissioners of LaPorte County, Indiana, that the following described real estate situated in LaPorte County, State of Indiana, to-wit:




be, and the same is, hereby vacated as a public way.


