

ORDINANCE NO. 8

**AN ORDINANCE TO VACATE A PORTION OF LILY LANE  
HUDSON TOWNSHIP, LAPORTE COUNTY, INDIANA**

WHEREAS, Dale A. Elkins and Samantha D. Elkins, as fee simple owners, have filed a petition, pursuant to I.C. 36-7-3-12, with the Board of County Commissioners of LaPorte County, Indiana, asking that a portion of Lily Lane in Hudson Township, LaPorte County, Indiana, be vacated, which portion is more particularly described as follows:

A portion of Lily Lane commencing at the Northeast corner of Lot 4611 and proceeding 101.55 feet southwesterly along the south border of Lily Lane to the Northwest corner of Lot 4615; thence North 30 feet across Lily Lane to the Southwest corner of Lot 4911; thence Northeast 101.57 feet along the north border of Lily Lane to the Southeast corner of Lot 4911; thence South 30 feet across Lily Lane to the Northeast corner of Lot 4611, the point of beginning, in Hudson Township, LaPorte County, Indiana.

and,

WHEREAS, following the filing of this petition the Board of County Commissioners scheduled a public hearing thereon to be held on April 22, 1996; and,

WHEREAS, the Clerk of the Board of County Commissioners of LaPorte County, Indiana, gave notice of the filing of this petition and of the hearing thereon by publication in the manner prescribed by I.C. 5-3-1-1 et seq; and,

WHEREAS, Petitioner's attorney provided notice of the filing of this petition and of the hearing thereon by certified mail return receipt requested upon all adjacent and interested property owners who own property abutting Lily Lane; and,

WHEREAS, the Board of County Commissioners, as the legislative body of LaPorte County, Indiana, has now conducted the public

hearing on the petition to vacate and has determined that a portion of Lily Lane, described above, should be vacated, all as permitted by I.C. 36-7-3-12;

NOW THEREFORE,

Section 1. BE IT, AND IT IS, HEREBY ORDAINED by the Board of County Commissioners of LaPorte County, Indiana, that the following described real estate situated in LaPorte County, State of Indiana, to-wit:

A portion of Lily Lane commencing at the Northeast corner of Lot 4611 and proceeding 101.55 feet southwesterly along the south border of Lily Lane to the Northwest corner of Lot 4615; thence North 30 feet across Lily Lane to the Southwest corner of Lot 4911; thence Northeast 101.57 feet along the north border of Lily Lane to the Southeast corner of Lot 4911; thence South 30 feet across Lily Lane to the Northeast corner of Lot 4611, the point of beginning, in Hudson Township, LaPorte County, Indiana.


be, and the same is, hereby vacated as a public way.




