

LAPORTE COUNTY ORDINANCE 1996- 21
ORDINANCE SETTING SPEED LIMIT IN SUBDIVISIONS

WHEREAS, Indiana Code 9-21-5-2 sets the presumed speed limits in urban areas at 30 miles per hour; and

WHEREAS, the LaPorte County Highway Engineer has reported to the Board of Commissioners that there is a need to designate urban areas and to establish speed limits in subdivisions.

NOW, THEREFORE, BE IT ORDAINED AS FOLLOWS:

Section 1. That all subdivisions approved after January 1, 1997, shall be deemed urban areas under Indiana Code 9-21-5-2, and unless specifically set to the contrary by ordinance, the speed limit on all County roads in said subdivision shall be 30 miles per hour.

Section 2. Roadways in subdivisions approved after January 1, 1997, shall not be accepted as County roads until the developer shall post all roads with speed limit signs noting the speed limit at 30 miles per hour. Said speed limit signs shall be placed at such locations as shall be directed by the LaPorte County Highway Department.

Section 3. That the following LaPorte County Subdivisions are designated as urban areas pursuant to I.C. 9-21-5-2, and the speed limit on County roads in said subdivisions shall be 30 miles per hour:




Section 4. This ordinance shall not apply to County Roads that existed prior to the subdivision being platted and which abut the subdivision.


Section 5. This ordinance shall be in full force and effect beginning the 1st day of JANUARY, 1997, and after its enactment and publication as prescribed by law.
