

**LAPORTE COUNTY COUNCIL MEETING**  
**November 22, 2010**

The LaPorte County Council Meeting was held on Monday, November 22, 2010, 6:30 p.m. in the Assembly Room of the LaPorte County Government Complex, 809 State Street, LaPorte, Indiana 46350.

Meeting was called to order by Council President, Mark Yagelski.

Pledge of Allegiance was recited.

Roll Call was taken by Auditor, Craig Hinchman. Those attending were Mr. Bernacchi, Mr. Cunningham, Mr. Garner, Mr. Ford, Mr. Yagelski, Mrs. Sosinski. and Mr. Mrozinski. Also present were Council Attorney, Don Baugher and Chief Deputy Auditor, Mary Ray.

The revised agenda was approved by all members.

The minutes from the County Council Meeting and the Budget Hearing held on October 25, 2010 were approved by all members.

**Department Head Reports**

Commissioner Barb Huston reported that she met with two additional companies regarding the Employee's free medical clinic. LaPorte Work Place and Memorial Hospital of South Bend. She will have more information later to present to the Council. She does recommend the Memorial Hospital of South Bend since they would be able to use the facilities of the Health Departments in both LaPorte and Michigan City. Making them more cost effective. She also attended the Data Board meeting, where they discussed a copy machine for in house printing, picture I D maker and the possibility of receiving grants for the e-mail compliance issue. She stated that the Commissioners have reached a settlement with two of the Dog Handlers from the Sheriff's department. Two additional Dog Handlers have consulted an attorney regarding their back pay. Negotiations are now in progress. She also stated that the dog program is a valuable tool in law enforcement, but very expensive. She doesn't think the County needs all three dogs.

President Yagelski asked her if the dogs had their own attorney yet.

President Yagelski thanked Commissioner Huston for the nice parking lot improvement at the Michigan City Court House.

Sheriff Mike Mollenhauer and Chief Deputy Jim Sosinski defended the dog program. They do realize that it is an additional expense but they are working on bringing the costs down. When they took office, they were not aware of a federal law about the Dog Program. Chief Sosinski has implemented rules to be within federal guidelines.

Mr. Cunningham asked Chief Sosinski how many dogs Porter, Starke & St. Joseph County have. Chief Sosinski did not know. Michigan City has three and LaPorte City has one. He then asked if they could consolidate and have fewer dogs.

Board of Education Superintendent, Norm Kleist reported that Prairie and Dewey schools have consolidated but Cass was still alone for now. He presented a proposal that the consolidated Prairie and Dewey will pay one half of his and his part time secretary's salary and benefits.

A motion was made to cut the salary and benefits by 50%.

After a heated discussion the motion was voted on

Mr. Garner voted no.

Mrs. Sosinski, Mr. Ford, Mr. Mrozinski, Mr. Yagelski, Mr. Cunningham and Mr. Bernacchi all voted in favor.

Motion approved

## **LIAISON REPORTS**

Mrs. Sosinski attended the Data Board meeting regarding a printer for in-house printing, the e-mail retention policy. The County is not in compliance, but no grant money is available. She also attended the Personnel meeting and re-addressed a Health Department employee evaluation. Human Resources will address this. It was recommended that all Health Department employees be re-evaluated, but it was determined to be unnecessary at this time.

Mr. Ford recommended the Emergency Management request for a replacement weather siren that cannot be repaired. He also is suggesting that the Court House Security request be tabled until more information is available.

Mr. Mrozinski reported meeting with the Animal Shelter and announced that Santa will be available for pictures with pets on December 4<sup>th</sup>, at the Lucky Dog.

Mr. Garner met with the Soil and Water Department. He stated that the cleaning of the Kankakee River is going well. He also stated that a part time employee is needed in this department.

Mr. Bernacchi recommended that the GIS request be approved and stated that the department does need another part time person. The Assessor is requesting funds to pay Tyler Group for the work that has been done on the reassessment. Mrs. McDaniel was not present but Assessor Elect, Mike Schultz stated that he is pleased with the progress that is being made.

Mr. Cunningham met with Community Corrections. Their request on tonight's agenda was removed. He also met with the Prosecutor.

Mr. Yagelski discussed the 2011 Council meeting schedule. (See the approved schedule attached) He also stated that N.I.C.T.D. could possibly receive \$800,000.00 in grant money for the study regarding the relocation of the South Shore in Michigan City.

Mr. Brian McKee from LaPorte Hospital stated that he was happy to answer any questions regarding the employee free clinic.
