

**LAPORTE COUNTY COUNCIL MEETING  
FEBRUARY 23, 2009**

The LaPorte County Council met in regular session the 23<sup>rd</sup> of February, 2009 in the assembly room of the LaPorte County Government Complex. The meeting was called to order by President Yagelski at 6:30 p.m.

The Pledge of Allegiance was recited.

Auditor Craig Hinchman had roll call and the following Council persons were present: Mr. Bernacchi, Mr. Cunningham, Mr. Garner, Mrs. Sosinski, Mr. Mrozinski and Mr. Yagelski. Council Attorney Don Baugher, Auditor Craig Hinchman and Chief Deputy Auditor, Mary Ray was also present. Mr. Ford was absent. Mr. Hinchman declared a quorum.

The Council approved the February 23rd, 2009 agenda.

The Council approved the January 26<sup>th</sup>, 2009 minutes.

**REPORTS OF DEPARTMENT HEADS**

Sheriff Michael Mollenhauer stated that he will be on the March Council Meeting agenda to request digital recording equipment maintenance. He stated that only two cameras work out of 205. He stated it is a security issue.

Health Department supervisor, Tony Mancuso stated his opinion in favor or the Springfield Sewer District.

Joie Winski president of the LaPorte County Property Tax Assessment Board of Appeals (PTABOA) requested that to streamline the appeals process, she wanted former Center Township Assessor, Michael Schultz and former Coolspring Township Assessor, Pam Kieft to be reappointed as hearing officers. She assured that they would keep regular hours or she will report back to the Council.

**LIAISON REPORTS**

Lois Sosinski reported she had meetings with HR and Data

Rich Mrozinski reported he had meetings with the County Home, Animal Control, Veteran Services, and Regional Sewer Board.

Terry Garner reported he had meetings with County Agent/Purdue Extension Office, Sheriff Mollenhauer and Commissioners Layton & Houston .

Matt Bernacchi reported he had meetings with G.I.S., Assessor Carol McDaniel and The Park Department.

Earl Cunningham reported he had a meeting with the Juvenile Service Center.

Mark Yagelski reported meeting with Coroner John Sullivan.

## PUBLIC COMMENTS

Tim Larson and Mark Danielson of Larson Danielson Construction voiced their concern about the bidding process for the building at the LaPorte County Fair Grounds. They question the legality of the awarding of the bid. If the project is to move forward, they are requesting to put the project up for new bids to meet state laws.

Mr. John Gilmore, President of Tonn & Blank Construction voiced his concerns about the proposed building at the LaPorte County Fair Grounds. He is upset that the contract signed by the Commissioners might not be honored by the County. He has already incurred expenses to comply with the bid.

Dennis Matheney stated that if Pam Kieft won't work regular hours on the PTABOA hearing appeals, she should resign. He also stated that since the Solid Waste District is not going to lease space at the Fair Grounds Building, if built, that the county should cut their loss and not proceeds with the building.

Commissioner Mike Bohacek stated that Nexus should not be paid the entire amount due because of a penalty deduction of \$300.00 per day. The amount needs to be recalculated before payment is made. They have not lived up to their end of the contract. Mike Kobos also spoke against paying Nexus. He stated that he has four parcels, he got eight different form 11's all in different envelopes wasting time, postage and paper. He stated that the reassessment job given to Nexus was never bid out properly, therefore should not be paid at all.

Several persons from the public strongly spoke out against the Springfield Sewer District.

Melissa Mischke requested \$185,100.00 from riverboat admissions fund 272-30162-000-272 for Aerial photography. Mrs. Sosinski and Mr. Bernacchi voted for, Mr. Mrozinski, Mr. Yagelski, Mr. Cunningham and Mr. Garner voted against. Request was denied.
